

## ORDER CALLING DIRECTORS ELECTION

BE IT ORDERED BY THE BOARD OF DIRECTORS OF GRAND LAKES MUNICIPAL UTILITY DISTRICT NO. 4 THAT:

**Section 1:** An election (the "Election") shall be held on the 4<sup>th</sup> day of May, 2024 ("Election Day"). At the Election there shall be submitted to the duly qualified resident voters of the aforesaid district (the "District") the matter of electing three (3) directors to the Board of Directors (the "Board") of the District.

**Section 2:** All qualified voters of the District shall be entitled to vote in the Election.

**Section 3:** The District hereby adopts by number, as its precincts for purposes of the Election, those election precincts established by Fort Bend County pursuant to Chapter 42, Texas Election Code, that overlap the District in whole or in part.

**Section 4:** The District has entered, or will hereafter enter, into written agreement(s) with Fort Bend County, Texas, for election services and for the purpose of conducting a joint election with other participating political subdivisions located, in whole or in part, in Fort Bend County, Texas, pursuant to Chapter 31 and Chapter 271, Texas Election Code (collectively, the "Joint Election Agreement"). The form(s) of the Joint Election Agreement are hereby approved in all respects. The President of the Board is hereby authorized to execute the Joint Election Agreement on behalf of the District. Any prior execution of the Joint Election Agreement by the President of the Board is hereby ratified and approved in all respects.

**Section 5:** As authorized by Chapter 31 and Chapter 271 of the Texas Election Code, and pursuant to the Joint Election Agreement, the Election shall be conducted by Fort Bend County, Texas. The District hereby appoints John Oldham, Fort Bend County Elections Administrator, to perform or to supervise the performance of any and all of the duties and responsibilities related to the conduct of the Election, as further specified in the Joint Election Agreement.

**Section 6:** As authorized by Chapter 31 and Chapter 271 of the Texas Election Code, and pursuant to the terms of the Joint Election Agreement, the District hereby appoints John Oldham, Fort Bend County Elections Administrator, as the Early Voting Clerk for the Election. Early voting by personal appearance for the eligible voters of the District shall be conducted at the locations and on the days and during the times set forth on Exhibit "A" attached hereto. Unless otherwise indicated on Exhibit "A", Rosenberg Annex Building, 4520 Reading Road, Rosenberg, Texas 77471 is hereby designated as the main early voting polling place. Applications for voting by mail shall be addressed to the Early Voting Clerk. The official mailing address and contact information of the Early Voting Clerk are as follows:

**Section 7:** Any eligible voter of the District may vote by personal appearance on Election Day, at the polling locations set forth on **Exhibit "B"** attached hereto. Voting by personal appearance on Election Day shall be conducted between the hours of 7:00 a.m. and 7:00 p.m., except as provided by Sections 41.032 and 41.033, Texas Election Code.

**Section 8:** Melia Berry is hereby appointed as the District's designated election agent (the "Election Agent") to perform election duties required pursuant to the provisions of Section 31.123, Texas Election Code, and Section 49.109, Texas Water Code. The duration of appointment of such Election Agent shall be from the date hereof until a successor is appointed, and the office hours of such Election Agent shall be from 9:00 a.m. to 5:00 p.m. daily, except Saturdays, Sundays or official state holidays. True and correct copies of all documents and materials pertaining to the Election shall be maintained on file in the office of Election Agent at 1300 Post Oak Boulevard, Suite 2400, Houston, Harris County, Texas 77056, open to inspection by the public or any person interested therein.

**Section 9:** Written application to have a person's name printed on the ballot as a candidate for the office of director of the District must be received by the Election Agent on or after January 17, 2024, but not later than 5:00 p.m. on February 16, 2024. Declarations of write-in candidacy must be received by the Election Agent not later than 5:00 p.m. on February 20, 2024.

No person's name shall be placed on the ballot unless he or she: is eighteen (18) years of age or older as of May 4, 2024; is a citizen of the United States; is a resident of the State of Texas; either owns land subject to taxation in the District or is a qualified voter within the District; has not been determined to be totally mentally incapacitated or partially mentally incapacitated without the right to vote by a final judgment of a court; has not been convicted of a felony from which he or she has not been pardoned or otherwise released from the resulting disabilities; has filed a loyalty affidavit with the Secretary of the Board or the Election Agent; and is not otherwise disqualified from holding such office. The Secretary of the Board and the Election Agent are authorized to review filings by candidates and determine the qualifications of candidates for office.

Any person not satisfied with said officer's ruling shall be authorized to appeal the decision to the Board.

Blank applications, declarations of write-in candidacy and copies of this Order may be obtained from the Election Agent.

**Section 10:** When the number of candidates exceeds the number of offices to be filled, the order in which the names of the candidates are to be printed on the ballot shall be determined by a drawing to be conducted by the Election Agent, who shall post notice in the District's office, at least seventy-two (72) hours prior to the scheduled time of the drawing, of the date, hour and place of the drawing, and shall also mail or e-mail notice of the date, hour and place of the drawing to each candidate, at the address or e-mail address, as applicable, stated on the candidate's application

for a place on the ballot, not later than the fourth (4<sup>th</sup>) day before the day of the drawing. Each candidate involved in the drawing, or his or her designated representative, shall have the right to be present and to observe the drawing.

Section 11: Pursuant to Sections 123.001 and 61.012 of the Texas Election Code, as amended, the District hereby adopts for use at the Election the Election Systems & Software EVS 6.2.1 Voting System, consisting of the ExpressVote Ballot Marking Device, ExpressTouch Electronic Tabulation Device, DS-200 Precinct Tabulator, and DE-450 Central Scanner, for voting or early voting by personal appearance, as same has been certified by the Texas Secretary of State as an accessible direct recording electronic voting system. In addition, pursuant to Sections 123.006, 63.011 and 125.006, Texas Election Code, the District authorizes the use of paper ballots to the extent necessary in connection with balloting by mail, provisional balloting, or in the event that an emergency prevents the use of the aforesaid direct recording electronic voting systems.

Ballots shall conform to the requirements of the Texas Election Code and be prepared and made available to voters in the English and Spanish languages.

Ballots shall have printed thereon the names of the candidates for the office of director. A qualified voter may vote for any three (3) or fewer persons for the office of director.

Section 12: This Order shall constitute the order for the calling of the Election and shall also constitute notice of the Election. The Election Agent is hereby authorized and directed to (i) deliver notice of the Election to the County Clerk and Voter Registrar of Fort Bend County, Texas, and/or the Elections Administrator of Fort Bend County, Texas, as applicable, not later than sixty (60) days before Election Day, and (ii) cause notice of the Election to be given by posting copies of this Order at a public place in each election precinct that is in the jurisdiction of the District, with said postings to be completed not later than twenty-one (21) days before Election Day (unless said day is a Saturday, Sunday or official state holiday and in which case it shall be posted on the next regular business day). In all such instances, copies of this Order shall be posted in the English and Spanish languages. Further, the Election Agent is hereby authorized and directed, to the extent applicable and if possible, to cause a notice to be posted at the entrance of the polling place for the District's previous election, which notice shall state that the polling location has changed and shall provide the location of the new polling place, all in accordance with applicable law.

Section 13: The Election shall be held and conducted and returns made to this Board in accordance with the laws of the State of Texas, including but not limited to, applicable provisions of the Texas Election Code and the Texas Water Code.

Section 14: The Board officially finds, determines and declares that this Order was reviewed, considered and adopted at a meeting of the Board beginning at 11:00 a.m., Houston, Texas time on January 17, 2024, and that a sufficient written notice of the date, hour, place and subject of this meeting was posted at the District's administrative office and at a place readily accessible and convenient to the public within the District and was timely furnished to the County Clerk of Fort Bend County, Texas, for posting on a bulletin board located at a place convenient to the public in the Fort Bend County Courthouse and on said Clerk's or County's Internet website, for the time prescribed by law preceding this meeting, as required by the Open Meetings Law,

Chapter 551, Texas Government Code, and Section 49.063, Texas Water Code, and that this meeting has been open to the public, as required by law, at all times during which this Order and the subject matter hereof has been discussed, considered and acted upon. The Board further ratifies, approves and confirms such written notice and the contents and posting thereof.

Section 15: The Board hereby reserves the right to amend or supplement this Order as deemed necessary and appropriate. The Board further reserves the right to cancel the Election if and as allowed in accordance with the provisions of Chapter 2, Subchapter C, Texas Election Code.

Section 16: Unless expressly provided otherwise, all references herein to the Texas Election Code or to the Texas Water Code shall mean and refer to such laws as amended and in effect as of the date this Order is passed and adopted.

Section 17: The President or Vice-President and Secretary or Assistant Secretary of the Board and the Election Agent are each hereby authorized and directed to take any action necessary to carry out the provisions of this Order. Further, the Election Agent, with the consent of the President of the Board, shall be authorized to correct Exhibit "A" and Exhibit "B" attached hereto to reflect any changes by Fort Bend County to the early voting polling information, including the main early voting polling place, and Election Day polling information set forth thereon, without need for amendment of this Order by the Board.

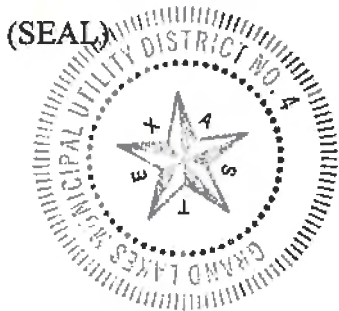

Por la presente, se ratifica y aprueba a todo efecto toda firma previa del Convenio de Elecciones Conjuntas por parte del Presidente de la Junta.

Sección 5: Como lo autorizan el Capítulo 31 y el Capítulo 271 del Código Electoral de Texas, y en virtud del Convenio de Elecciones Conjuntas, la Elección será celebrada por el Condado de Fort Bend, Texas. Por la presente, el Distrito designa a John Oldham, Administrador de Elecciones del Condado de Fort Bend, para realizar o supervisar el cumplimiento con todas y cada una de las obligaciones y responsabilidades relacionadas con la celebración de la Elección según se especifique adicionalmente en el Convenio de Elecciones Conjuntas.

**Sección 9:** La solicitud escrita para que el nombre de una persona aparezca impreso en la boleta de votación como candidato para el cargo de director del Distrito debe ser recibida por el Agente Electoral a partir del 17 de enero de 2024, inclusive, hasta las 5:00 p.m. del 16 de febrero de 2024 a más tardar. El Agente Electoral debe recibir las declaraciones de candidatura por escrito hasta las 5:00 p.m. del 20 de febrero de 2024 a más tardar.

No se colocará el nombre de ninguna persona en la boleta de votación a menos que él o ella: tenga dieciocho (18) años de edad o más para el 4 de mayo de 2024; sea ciudadano/a de Estados Unidos; sea residente del Estado de Texas; sea propietario/a de terreno sujeto a impuestos en el Distrito o sea votante habilitado/a dentro del Distrito; no haya sido declarado/a total o parcialmente incapacitado mental sin derecho al voto por el fallo final de un tribunal; no haya sido condenado/a por un delito grave del cual él o ella no haya sido indultado o librado de alguna otra forma de las discapacidades resultantes; haya presentado una declaración jurada de lealtad ante el Secretario de la Junta o ante el Agente Electoral; y no esté inhabilitado/a de alguna otra forma para ocupar dicho cargo. Sección 11: En virtud de las Secciones 123.001 y 61.012 del Código Electoral de Texas y sus enmiendas, por la presente, el Distrito adopta para uso en la Elección el sistema de votación Election Systems & Software EVS 6.2.1, formado por el dispositivo de marcación de boletas ExpressVote, el dispositivo de tabulación electrónica ExpressTouch, el tabulador de precintos DS-200 y el escáner central DE-450, para la votación o la votación anticipada en persona, ya que este ha sido certificado por la Secretaría del Estado de Texas como un sistema de votación electrónica de registro directo y accesible para discapacitados. Además, en virtud de las Secciones 123.006, 63.011 y 125.006 del Código Electoral de Texas, el Distrito autoriza el uso de boletas de votación de papel en la medida necesaria en relación con la votación por correo, para los votos provisionales o en el caso de que una emergencia impida el uso de los mencionados sistemas de votación electrónica de registro directo.
