

GRAND LAKES MUNICIPAL UTILITY DISTRICT NO. 4
NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District (the "Board") will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Texas 77056, said address being an official meeting place of the District.

The meeting will be held on **Wednesday, August 21, 2024, at 11:00 a.m.**

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:

1. Public comments;
2. Review and approval of the minutes of the Board meeting of July 17, 2024;
3. Review and discussion of the monthly activity reports prepared by the Fort Bend County Sheriff's Office and Fort Bend County Precinct 1 Constable's Office, including:
 - A. Review and approve proposed 2024-2025 Interlocal Law Enforcement Services Agreement with Fort Bend County for the Fort Bend Precinct 1 Constable deputy patrol services contract effective October 1, 2024, through September 30, 2025;
4. Receive the Financial Advisor's recommendation concerning the District's proposed 2024 tax rate, determine intended tax rate, and authorize:
 - A. the required public notice that the Board will consider adoption of a tax rate; and
 - B. the means of providing such notice;
5. Engagement of auditor to audit the District's financial statements and prepare the District's audit report for fiscal year ending August 31, 2024 and acceptance of Texas Ethics Commission Form 1295 (the "TEC Form 1295");
6. Bookkeeper's Report, including financial and investment reports; authorize the payment of invoices presented;
7. Adoption of operating budget for fiscal year ending August 31, 2025;
8. Discussion of presentations received from electricity brokers, and take any action necessary in connection therewith;
9. Tax Assessor-Collector's Report, including status of delinquent taxes; authorize the payment of invoices presented, approval of tax refunds, and transfer of accounts to the uncollectible roll;
10. Discussion regarding collection and use of Strategic Partnership Agreement revenues;
11. Review of Delinquent Tax Collection Attorneys' Report from Perdue, Brandon, Fielder, Collins & Mott, L.L.P.; authorize any action necessary and appropriate in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;

12. Operation and Maintenance Report, including:
 - A. Monthly report;
 - B. Appeals of District charges and other customer billing matters;
 - C. Repair and maintenance of District facilities, including consideration of any contracts for same and authorize acceptance of TEC Form 1295;
 - D. Refer accounts for collection;
 - E. Approve write-off of uncollectible accounts;
 - F. Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - G. Discussion of assumption of electrical accounts for irrigation controllers from the Grand Lakes Community Association to the District and authorize contact with the District's energy broker regarding same;
 - H. Reclaimed water system and irrigation;
 - I. Status of the technology upgrades to the irrigation system; and
 - J. Discuss timing of invoices to Grand Lakes Municipal Utility District No. 1 and No. 2;

13. Consider Annual Consumer Price Index Adjustment to Service Agreement by and between the District and Municipal District Services, L.L.C.;

14. Engineer's Report, including:
 - A. Authorizing the design and/or advertisement for bids for construction of facilities within the District, and approving of related storm water plans;
 - B. Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of the District, and the execution of any documentation in connection therewith, including wastewater treatment plant site permit;
 - C. Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, approval of any related storm water permits, and authorize acceptance of TEC Form 1295;
 - D. Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders and authorize acceptance of TEC Form 1295;
 - E. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes; and
 - F. Discuss improvements to dirt driveway, located at the west end of the Frog Park leading to the District's Lift Station; and
 - G. Discussion of Reclaimed Irrigation System, including:
 - i. Discussion of reclaimed water emergency interconnect and review of cost estimate relative to same; and
 - ii. Review estimate to connect new waterline to Reclaimed Ground Storage Tank for backup water source;

15. Request for issuance of utility commitments;

16. Discussion regarding Community Engagement Event with the Board of Directors of Grand Lakes Municipal Utility District No. 1 and Grand Lakes Municipal Utility District No. 2;

17. Discuss request for funding Cinco Ranch Boulevard Trail Underpass Project;

18. District's Communications Report;
19. Discuss compliance with the EPA Phase II Small MS4 General Permit, including any training necessary under the storm water management plan;
20. Attorney's Report;
21. Convene Closed Session for consultation with attorney regarding pending or threatened litigation or matters protected by attorney-client privilege pursuant to Section 551.071; as amended;
22. Reconvene in Open Session and authorize any actions related to matters discussed in Closed Session;
23. Take action on matters discussed during Closed Session; and
24. Matters for possible placement on future agendas.
